No. 72-Edn(CS), dt. 17-01-1997, No. 63-Edn(CS), dt. 12-01-1999 and No. 195-Edn(CS), dated 11-02-2000 (Bunching effect) and No. 629-Edn(CS), dated 12-05-2000.

The date of increment of a Teacher will be deferred by the period of which he / she is granted leave without pay in any year.

In this connection, it may please be noted that the Teacher(s) drawing pay in this revised scale (i.e. in the new U.G.C. scale of pay (1996)) must retire on completion of 60 years of age.

Necessary adjustment on account of ad-hoc payment, if any, will be made against the claims admissible in terms of this pay fixation. The net amount after such adjustment shall be disbursed.

If it is eventually found that payment on account of this pay fixation has been made wrongly for any reason in excess of the admissible amount, such excess payment, if any, shall be recovered from the future claims of the teacher(s) concerned.
