### **Objectives of the MOU**

1. To promote and enhance academic exchange and cooperation between the institutes through relevant departmental faculty exchange.
2. To promote collaborative research work in basic science, humanities and other emerging skills.
3. Collaborative work through extended and continuing education activities between the institutes for short term courses.
3. To collaborate in organizing joint Workshops and Conferences.
4. To avail internship in Technical knowledge of management and computer science of 1<sup>st</sup> institute students to the 2<sup>nd</sup> institute.

### **Terms and Conditions**

1. Initially the MOU will be effective for **five years** but may be extended if mutually agreed by both the institutes.
2. This MOU may be amended, renewed or written terminated by mutual agreement of the institutes at any time.
3. Either institute shall have the right to terminate this MOU upon 60 days prior written notice to the other institute.
4. Nothing contained in this MOU shall infer or create for either of the institutes, any right over the intellectual or physical property of the other institute.
